

Directions

From South Huntsville

- 1. Take Memorial Parkway north (U.S. 231) toward downtown Huntsville.
- 2. Take the Clinton Avenue exit. (If you get to I-565, you've gone too far.)
- 3. At the bottom of the ramp, turn **left** onto Clinton Avenue.
- 4. After you go under the overpass for Memorial Parkway, turn into the parking lot for the first building on the left. (This building is now called the Commerce Center, but was formerly the headquarters building for SCI.)
- 5. Our offices are on the first floor. Once you enter the building, our reception area will be on the left.

■ From North Huntsville ■

- 1. Take Memorial Parkway south toward downtown Huntsville.
- 2. Take the Clinton Avenue exit.
- 3. At the bottom of the ramp, turn **left** onto Clinton Avenue.
- 4. Turn into the parking lot for the first building on the left. (This building is now called the Commerce Center, but was formerly the headquarters building for SCI.)
- 5. Our offices are on the first floor. Once you enter the building, our reception area will be on the left.

From Huntsville International Airport in the second sec

- 1. Take Interstate 565 east to Huntsville.
- 2. Take Exit 19A off of Interstate 565. At this point, the signs will be directing you to U.S. 231 South, U.S. 431 South, and Memorial Parkway South (all the same road).
- 3. Take the Clinton Avenue exit. (This follows very soon after exiting from the Interstate.)
- 4. At the bottom of the ramp, turn **left** onto Clinton Avenue.
- 5. Turn into the parking lot for the first building on the left. (This building is now called the Commerce Center, but was formerly the headquarters building for SCI.)
- 6. Our offices are on the first floor. Once you enter the building, our reception area will be on the left.

■ From Hampton Cove ■

- 1. Take U.S. 431 (Governors Drive) west toward the Parkway.
- 2. At the intersection of Governors Drive and the Parkway, turn right onto the Parkway service road. (Don't get on the Parkway; remain on the service road.)
- 3. At the intersection of the service road and Clinton Avenue (at the traffic light), turn **left** onto Clinton Avenue. Go under the overpass.
- 4. Turn left into the parking lot for the first building on the left. (This building is now called the Commerce Center, but was formerly the headquarters building for SCI.)
- 5. Our offices are on the first floor. Once you enter the building, our reception area will be on the left.

From Atlanta

- 1. From Atlanta, take Interstate 75 **north** to Chattanooga.
- 2. In Chattanooga, take Interstate 24 **west** and go through Chattanooga. Warning: West of Chattanooga, do **not** turn on Interstate 59 south. Instead, continue on Interstate 24 to U.S. 72. They intersect near a little town called South Pittsburg, TN.
- 3. At South Pittsburg, take U.S. 72 west to Huntsville.
- 4. U.S. 72 becomes Interstate 565 near downtown Huntsville. Near downtown Huntsville, there is a sign indicating how to turn to continue onto U.S. 72. Do **not** turn at that point. Continue straight ahead.
- 5. Take Exit 19B. This is the exit for U.S. 231, U.S. 431, and Memorial Parkway (all the same road). The ramp for this exit is very long and confusing. Carefully follow the signs so that you go **south** on U.S. 231, U.S. 431, and Memorial Parkway. This ramp will go over Memorial Parkway and then have a long curve to the left.
- 6. Take the Clinton Avenue exit. (This follows very soon after exiting from the ramp for I-565.)
- 7. At the bottom of the ramp, turn **left** onto Clinton Avenue.
- 8. Turn into the parking lot for the first building on the left. (This building is now called the Commerce Center, but was formerly the headquarters building for SCI.)
- 9. Our offices are on the first floor. Once you enter the building, our reception area will be on the left.
